Art on the Square is a series of four juried shows on the streets surrounding Courthouse Square in the heart of downtown Redwood City.

Art on the Square complements:

- **Music on the Square**, Redwood City's Friday evening summer concerts,
- **The PAL Blues Festival** in July benefiting the Police Activities League, and
- **The Redwood City Salsa Festival** in September.

Each of these popular events draws large crowds. To increase sales we hold a drawing at each show for gift certificates that winners can spend at the artist's booth of their choice.

Fine art & fine craft only All items sold must be created by the vendor. No buy and sell accepted. The artist must be present in their booth during the show(s).

Booths & displays Vendors must provide their own display set-up: booth, panels, tables, chair, etc.

Jury fee \$5 per show or \$15 for four shows. *NOTE: If you initially apply to fewer than four shows and later decide to apply to additional shows, you will be charged the \$5 jury fee per show. You will not be eligible for the flat rate of \$15 for four shows.*

Cancellations No refunds given for cancellations received less than 30 days prior to the date of the show.

Cancellations received 30 days or more prior to the date of the show will be refunded as follows:

June or Aug shows: 10' x 10', \$30 or 10' x 20', \$60

July or Sept shows: 10' x 10', \$125 or 10' x 20', \$250

Jurying We look for the highest quality work and strive to have a variety of media represented at each show.

Images Four color photos (min 4" x 6", max 8" x 12") of your current work and one color photo of your booth.

Checks One check for jury fee(s) and separate checks for each show requested made payable to Beth Mostovoy.

SASE (Self Addressed Stamped Envelope) large enough to hold checks and photos with correct postage. If not accepted, checks for shows requested and photos will be returned in your SASE. If accepted, photos will be returned the day of event.

Deadline When filled. Monthly jurying for all shows.
